## CODE OF CONDUCT

### Youth Waiver

The Scottsbluff Family YMCA reserves the right to review any inappropriate behavior and conduct and deny access or membership to **any member or guest** at the discretion of Y management. I understand that my child(ren) (named below) will be held accountable in instances of inappropriate behavior in the following way: minor offenses, as determined as such by the YMCA Staff, will receive **ONE VERBAL WARNING**, if a repeat offense occurs, the member / guest will be asked to leave the premises immediately and the parents / guardians will be contact. In the case of blatant offensives, the member / guest will be asked to leave, and the parents / guardians will be contacted. I agree that should any second event of an inappropriate act or first occurrence of any blatant act occur, that my child(ren) will be asked to leave the premises immediately and the care and transportation of my child(ren) becomes solely my responsibility. I also understand that as a consequence my child(ren)'s and/or my membership may be terminated. I further understand that YMCA management has the authority to amend policies and procedures at any time to ensure the delivery of the highest possible services to the general membership.

I understand that YMCA activities have inherent risks and in consideration for membership at the YMCA and participation in YMCA programs I hereby assume all risks and hazards incident to my participation in all YMCA activities, due to the negligence of the YMCA or otherwise while in, about, or upon the premises of the YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the YMCA, including volunteer service. I further waive, release, absolve, indemnify, and agree to hold harmless the YMCA, the organizers, volunteers, supervisors, officers, directors, participants, coaches, referees, as well as persons or parents transporting participants to and from activities from any claims or injury sustained during my use of the YMCA property or participation in programs. I expressly assume all dangers, risks, and hazards to me and all minors in my care.
